APPLICATION PROCESS 2024

RECRUITMENT CONDITIONS

Admissions are open for entry in MSc 1st year and MSc 2nd year.

❖ Entry for the Master 1st year

Candidates graduated with a French diploma or a foreign diploma

- Hold a valid Bachelor's degree (180 ECTS or equivalent). Candidates must have validated their Bachelor's degree by October 31st, 2024 at the latest. They must provide a certificate of completion or a copy of their diploma to the school.

OR

- Hold 120 ECTS or equivalent with a professional experience of 2 to 5 years in the hotel and/or F&B industries.

❖ Entry for the Master 2nd year

Candidates graduated with a French diploma or a foreign diploma

- Hold 240 ECTS.

If you choose the bilingual course (French/English) and you are a non-French speaker, you will have to provide a document attesting your B2 level in French at the TEF (Test d'Evaluation du Français) or the DELF (Diplôme d'Etudes en Langue Française).

If you choose the English course and you are a non-native English speaker, you must provide proof of a TOEIC (listening and reading) score of at least 785 points or an IELTS score of level 6.5.

Since it can take several months to obtain the documents and to pass the language certification, we advise you to make the request as soon as you pre-register or apply on the MSc program.

If you have a temporary or permanent disability, or if you suffer from a disabling health problem, FERRANDI Paris wants to ensure that your recruitment process will take place in the best possible conditions. SUBMISSION OF THE APPLICATION

You can apply directly on each campus website. Campus of Paris will open application submission from **Thursday, November 23, 2023** at **10:00 am**, through our website: www.ferrandi-paris.com/en.

You will receive the confirmation of your application and a login to track the progress of your application. An email will be sent to you with an application file.

You must submit the following documents on the application platform:

- merged in one pdf file, a cover letter mentioning course chosen, language preferred and year and a detailed resume,
- in one pdf file, the ID card or copy of your passport,
- merged in one pdf file, grade transcripts of the last two years of study in higher education,
- merged in one pdf file, specific documents, i.e., any document that could enrich your application, including language certification (letters of recommendation, GMAT, TOEIC, etc.),
- proof of payment of the non-refundable application fee. Without this proof, your application will not be examined.

As registrations for the interviews are made as applications are received, we suggest
that you submit your application as soon as possible

SELECTION OF APPLICATIONS AND INTERVIEW PROCEDURES

❖ Selection of applications

The eligibility jury selects candidates whose academic record provides sufficient guarantees for the pursuit of higher education. It may refuse eligibility to a candidate:

- whose application file is incomplete,
- whose academic record and/or professional experience would reveal an unsuitable profile,
- who have not been able to provide proof of the equivalence of their years of study,

The candidate's eligibility is determined after studying the complete file.

After studying your file, you will receive an email informing you of the outcome of your application.

❖ Interview

The purpose of these interviews is to assess the candidate's open-mindedness, adaptability, professional and personal plans, and ability to take advantage of the full program to start the career for which the program prepares. The interview will be conducted in both French or English depending on the track chosen for the 1st year of Master, and in English exclusively for the 2nd year of Master.

Interviews take place on the preferred campus or by video conference in case of impossibility to travel. Candidates who are declared

eligible must attend these tests with their invitation and an ID card or Passport.

Motivational interview in English and/or French	30 min

The jury is conducted face-to-face by FERRANDI's Dean or representative (manager of the training, academic director), who acts as Chairman of the Jury, two hospitality professionals and one teacher.

The calendar of the interviews for Paris Campus will be available from December 5, 2023, on our website and is updated regularly. For other campus, please refer to their website.

❖ Admission

At the end of the interviews of each recruitment session, the admission jury, composed of the MSc representative, campus director and academic director, draws up the first list of admitted candidates. The jury then draws up a supplementary list of candidates who may be called upon, depending on their ranking.

Admission is valid only for the academic year following the recruitment session. However, in exceptional cases, the candidate who has been admitted may keep the benefit of his/her admission for the following year. He/she must explain the reasons for his/her request in writing to the Academic Manager no later than July 8, 2024, who will judge the relevance of the request.

Candidates who are not admitted will have the opportunity to retake the selection interview the following year. In this case, they must send a new application.

PUBLICATION OF RESULTS AND CONFIRMATION OF ADMISSION

The results will be available on the application platform within two weeks following the recruitment sessions. At the same time, you will receive an e-mail informing you of the jury's decision (admitted, waiting list, not admitted).

In order to validate their registration, admitted candidates must:

❖ Return, at the latest **within 2 weeks after the notification of admission** or **at the deadline indicated in the email**, the signed payment commitment,

❖ And pay a deposit:

- Entry in 1st year: 4,100€
- Entry in 2nd year: 6,000€

If you do not reply within the time limit indicated,
your application will be cancelled.

BACK-TO-SCHOOL

First day of the academic year and official back-to-school: beginning of September 2024

APPLICATION FEES

The application fee of 150€ (limited to 50€ for students with higher education scholarship), non-refundable, must be paid online at the following address:

Without payment of the application fee, your application will not be considered.

TUITION FEES

The tuition fees for the Master of Science's degree with entry in 1st year represent 13,500 €.

The tuition fees for the Master of Science's degree with entry in 2nd year directly represent 20,000 € (in following of the 1st year, tuitions are 15,000€ for the 2nd year).

This price does not include:

- Meal expenses (in France and abroad)
- Payment of the CVEC (Contribution de Vie Etudiante et de Campus)
- Transportation and accommodation during travels in France or abroad

TERMS OF PAYMENT

Training	Deposit	Balance
Master 1 st year	4,100€	9,400€
Master 2 nd year	6,000€	14,000€

Deposit at registration (incl. one-year deferred registrations), non-refundable except in case of failure of the diploma required of entry in 1st year or 2nd year.

Balance of the year payment:

- In case of completion of the Financial file and cash payment of the tuition fees balance at least 30 days before the academic year begins (and no later than 7 days before this date), a discount may be applied by the School for the applicant. The amount of this discount will be indicated on the invoice.
- By 5 monthly withdrawals from October 10th, 2024.

Once the training has begun, the training fees are due in full, even if you leave during the year.

Visa refusal for foreign applicants

The deposit can be refunded in case of a visa refusal by the French Consulate. Proof of this refusal must be provided for us to proceed with the refund. This does not apply in the case of late submission of a visa application or failure to comply with visa application procedures.

Deferral conditions

If a deferred student is unable to attend the next session of the program, the full tuition deposit will be withheld, and no refund will be issued.

Exceptions and force majeure

Exceptions to the above-mentioned postponement and withdrawal conditions may be made on a case-by-case basis, at the discretion of FERRANDI Paris management, in the event of force majeure or unforeseen circumstances.

❖ Student Loans
